- (ii) Applications submitted by candidates belonging to the communities other than those included in this Notification will be summarily rejected. No rejection memo will be issued to these candidates.

- (iii) Separate Ranked Lists will be prepared for the above Districts in pursuance of this notification. - (iv) The candidates belonging to above reservation communities shall submit application for this post to the districts concerned where the vacancy is in existence for their respective communities and shall note the name of that district against the relevant column in the online application. Applications should not be submitted to more than one district in response to this notification. If applications are submitted contrary to the above direction, and if he/she is selected, his/her name will be removed from the Ranked List and disciplinary action will be taken against him/her.
- (v) The selection in pursuance of this notification will be made on a Revenue District basis, subject to the special conditions laid down in G O (MS) No. 154/71/PD dated 27.05.1971. A candidate advised for appointment in one Revenue District from the Ranked List prepared is not eligible for transfer to another district unless he/she completes five years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subjected to the rules in G O (MS) No.4/61/PD, dated 2.1.1961. Candidates already in Government Service holding the same post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.

ii) Muslim, LC/AI, SIUC Nadar, Dheevera, Hindu Nadar :- 18-39. Candidates born between 02.01.1977 and 01.01.1998 (both dates included) are only eligible to apply for this post.

(Including the relaxation as per para 2(i) of the General Conditions)

iii) OX:- 18-41 . Candidates born between 02.01.1975 and 01.01.1998 are only eligible to apply for this post in the case of OX candidates. (Candidates belonging to adult members of

scheduled castes and their children when such adult members are converted to Christianity).  
(Including the relaxation as per para 2(i) of the General Conditions)

## 2. Ayurveda Colleges

i) ST:- 19-41 . Candidates born between 02.01.1975 and 01.01.1997 (both dates included) are only eligible to apply for this post.

ii) Muslim, LC/AI, SIUC Nadar, Dheevara, Hindu Nadar :- 19-39. Candidates born between 02.01.1977 and 01.01.1997 (both dates included) are only eligible to apply for this post.

(Including the relaxation as per para 2(i) of the General Conditions)

iii) OX:- 19-41. Candidates born between 02.01.1975 and 01.01.1997 are only eligible to apply for this post in the case of OX candidates. (Candidates belonging to adult members of scheduled castes and their children when such adult members are converted to Christianity).

(Including the relaxation as per para 2(i) of the General Conditions)

Note :- For concessions allowed in upper age limit, subject to the condition that the maximum age limit shall in no case exceed 50 years, please see para (2) of the General Conditions under Part II of this Notification (except para 2(i)).

## 7. **Qualifications:-**

### 1. Indian Systems of Medicine / Ayurveda Colleges

(i) Pass in SSLC or equivalent qualification.

(ii) Diploma/Certificate in Ayurveda pharmacist course recognised by the Government of Kerala.

### 2. Insurance Medical Services

Certificate of Ayurveda Pharmacist Course recognised by the Government.

Note:- KS&SSR Part II Rule 10 a(ii) is applicable for selection to this post.

## 8. Mode of submitting Applications :-

Candidates must register as per “ ONE TIME REGISTRATION” with the Official Website of Kerala Public Service Commission '[www.keralapsc.gov.in](http://www.keralapsc.gov.in)' before applying for the post. Candidates who have registered can apply by logging in to their profile using their User-ID and password. Candidates must click on the `Apply Now' button of the respective posts in the Notification Link to applying for a post. The photograph uploaded should be one taken after 31/12/2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link Registration Card in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile, candidates must ensure the correctness of the information on their profile. They must quote their User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The Application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to

prove Qualification, experience, Community, age etc. have to be produced as and when called for.
