Applicants are advised to read all instructions carefully before filling up the applications.

1. These posts carry usual allowance as admissible to the Central Government employee and as made applicable to Institute for Post Graduate Teaching & Research in Ayurveda (IPGT&RA) employees.
2. The applicant must be a citizen of India.
3. All applicants must fulfil the essential requirements of the post and other conditions stipulated in the advertisement as on the last date of receipt of the applications. They are advised to satisfy themselves before applying that they possess essential criteria laid down for various posts. No enquiry or advice will be entertained asking for eligibility.
4. The prescribed essential criteria is minimum and mere possession of the same does not entitle candidates to be called for screening/interview. The competent authority reserves the right to shortlist candidates on the basis of higher qualifications/year of experience in the subject/screening test/other criteria.
